Purpose

Attached is the final Cabinet paper on the Technical Advisory Group's (TAG) national structures recommendations. The revised Cabinet paper incorporates your feedback and feedback from our consultation with agencies.

This briefing summarises the feedback received from agencies and the changes that we have made as a result. If you are comfortable with the revised documents, we ask that the Minister of Civil Defence's office consult Ministerial and coalition colleagues on the paper.

When the Ministerial and coalition consultation process is complete, we will make any changes needed. We will then seek your authorisation to lodge the paper with the Cabinet Office by 10am on 28 February 2019 for consideration by the Cabinet Governance and Administration Committee (GOV) on 7 March 2019.

The next meeting of GOV is on 21 March 2019. Papers for this meeting need to be lodged on 14 March 2019.

We have finished agency consultation on the Cabinet paper

- 1. On 23 November 2018, we sent you a draft Cabinet paper about the proposed response to the Technical Advisory Group's (TAG) report recommendations on emergency management national structures [DPMC 1819NSP/054 and SSC2018/1085 refer].
- 2. As agreed with the Minister of Civil Defence, the draft Cabinet paper was based on the advice provided in the Department of the Prime Minister and Cabinet's (DPMC) briefing *Delivering Better Responses to Emergencies: National Structures* [DPMC 1819NSP/040 refers]. In putting together the draft that we provided you in November, all agencies were sent the front end of the paper and the sections of the paper that directly related to them (e.g. agencies with proposed lead agency responsibilities). Agencies did not see the machinery of government or financial implications sections. Where agencies responded, their feedback was included in the draft we sent you.
- 3. Since sending you the draft Cabinet paper, we have followed up with agencies that did not provide feedback on the earlier document and with agencies with known concerns. The State Services Commission (SSC) also gave the Hazard Risk Board a verbal update on the machinery of government proposals. This feedback, along with the feedback received from you/your office is included in the final draft Cabinet paper which is attached to this briefing.

We have made two main changes to the Cabinet paper that you saw in November

Location of the proposed departmental agency

- 4. This section was blank in the previous version of the Cabinet paper as Ministerial and agency discussions on this point were still ongoing. The Cabinet paper (paragraphs 32-34) now includes a section on this that we understand reflects Ministerial conversations and the Minister of Civil Defence's conversation with the Chief Executive of DPMC. The Chief Executive of DPMC has discussed this position with the State Services Commissioner and the Chief Executive of the Department of Internal Affairs (DIA) who are both comfortable with the position proposed in the paper.
- 5. This section now proposes that the new national emergency management agency (NEMA) is set up as a departmental agency within DPMC in the first instance and that this will be reviewed with you^{9(2)(f)(iv)}, once the new agency has been up and running for a year.

6. We have also included a paragraph about why Fire and Emergency New Zealand (FENZ) is not considered as the host for NEMA.

Establishment of the agency – timing and budget

7. The Cabinet paper that you saw in November proposed that a departmental agency of the same size of the Ministry of Civil Defence & Emergency Management (MCDEM) be

set up within the Department of the Prime Minister and Cabinet (DPMC) from 9(2)(f)(iv). It was noted that this could be done at minimal cost and that this could be funded through internal reprioritisation.

- 8. It is now clear that while it <u>may be</u> possible to absorb the costs required to set up the departmental agency within existing baselines, there are likely to be ongoing running costs that could not be absorbed (given DPMC's reducing baseline in coming years). Therefore setting up a new agency with no new money would not be sustainable.
- 9. The Treasury advise that if any new money is required for this initiative then it must be considered through the Budget process and Cabinet will not be able to agree to set up the agency before Budget decisions are made. Therefore, the Cabinet paper seeks agreement agree in principle to setting up a departmental agency within DPMC subject to investment being available through Budget 2019. We have also changed the establishment date to ^{9(2)(f)(iv)} to reflect the dependence on the Budget process.

We have also made changes that relate to agency feedback – these are not substantive

- 10. The table in Appendix 1 sets out the agencies that we consulted. A high-level summary of their feedback is provided along with the action we have taken in the Cabinet paper. The main changes are:
 - Inclusion of definitions in a footnote on page one of the paper as there is confusion as to what is meant by emergency management and emergency.
 - Changes to the description of national emergency management agency's (NEMA) role (paragraph 19) to emphasise its role working across central government as well as with local government and communities.
 - Addition of wording to reference NEMA's role in risk reduction (paragraph 21).
 - Inclusion on a section (paragraphs 39-41) on how agencies will be engaged in the process after Cabinet has made decisions on NEMA.

Next steps

- 11. Once you are comfortable with the revised document, we ask that the Minister of Civil Defence's office consult Ministerial and coalition colleagues on the paper. To support the Ministerial consultation we will provide a copy of the Cabinet paper to members of the Hazard Risk Board and the chief executives of other relevant agencies.
- 12. When the Ministerial and coalition consultation process is complete, we will make any changes that are needed. We will then seek your authorisation to lodge them with the Cabinet Office by 10am on 28 February 2019 for consideration by the Cabinet Governance and Administration Committee (GOV) on 7 March 2019.
- 13. The next meeting of GOV is on 21 March 2019. Papers for this meeting need to be lodged on 14 March 2019.
